MONTHLY STOCK PERFORMANCE REPORT OVERVIEW OF MARKET PERFORMANCE BY PEER GROUP

As of April 30, the number of banks remained constant in the Monthly Stock Report, as no banks were dropped from coverage during the month. This left the overall total count at 94 banks. Group composition otherwise held constant across all categories.

Under \$150M —5 Banks

Group count held constant over the period, as no new banks were added to or dropped from the group, leaving the total number of banks covered at 5 for the assets under \$150M group. Of the five publicly-traded banks with assets under \$150M, 2 banks saw gains in stock price, 1 declined, and 2 were unchanged. One stock saw significant gains in excess of 10% during the period: CABB, which was up 22.2%. The average Price-to-Tangible-Book Value (P/TBV) was down slightly during the month, closing at 0.83x. The Price-to-Earnings Ratio (P/E) is not reported. P/TBV ratio is comprised of only two of the four banks.

\$150M-\$250M -11 Banks

The overall count remained constant in the \$150M—\$250M range during the period leaving the count at 11 banks. Of the 11 publicly-traded banks in the asset range, 4 reported monthly gains in stock price, 3 declined in price, and 4 were unchanged. No bank reported a gain in stock price over 10% in the month of April. The average P/TBV ratio for banks between \$150—\$250M was down slightly over the month, closing at 1.17x. P/E, however, increased, closing April at 17.39x, and is now the highest ratio across all asset categories.

\$250M-\$500M —18 Banks

Group count held steady in the \$250M—\$500M asset range, as there were no acquisitions and group composition also remained constant. Of the 18 publicly-traded banks in the category, 12 experienced gains in monthly stock price, and 5 sustained price declines and 1 was unchanged. No banks in the category reported significant price gains over 10% during the period. P/TBV ratio was mostly flat, closing the month at 1.18x. P/E ratio increased slightly, ending the month at 14.70x. P/E is no longer the highest ratio across all categories.

California Banks: Overview of Market Performance by Asset Group for March 2019

\$500M-\$1B — 18 Banks

Group count and composition remained constant for the \$500M—\$1B asset range during the month, leaving the total count at 18 banks. Of the 18 companies, 6 recorded stock price gains, 10 declined in stock price and 2 were unchanged. One bank reported significant price gains over 10% for the asset category during the period: PLBC, which was up 14.7%. P/TBV was down during the month, closing at 1.48x. P/E was also down ending the month at 13.81x.

\$1B-\$5B —23 Banks

Group count held steady over the period, leaving the count at 23 banks for the \$1B—\$5B group. For the 23 remaining companies in the group, 18 reported stock price gains, 4 declined in stock price, and 1 was unchanged. No banks reported significant price gains over 10% for the period. P/TBV was up slightly for the category, closing the month at 1.49x. P/E was also up, ending the month at 12.68x.

\$5B-\$10B — 10 Banks

Group count remained constant for the \$5B—\$10B asset category during the month of April. Of the 10 banks in the asset range, 9 banks reported a stock price gain and 1 was unchanged. Three banks reported significant price gains over 10% for the period: AX (13.0%), HAFC (11.5%), and OPB (10.5%). P/TBV was up for the category, ending the period at 1.49x. P/E was up sharply, closing April at 16.53x.

\$10B-\$100B — 9 Banks

Both the count and composition of the group held steady during the month. Of the 9 banks in the category, all 9 banks increased in price during the period. One of the banks in the category reported significant price gains over 10% for the period: SIVB, which was up 13.2% in April. P/TBV was up for the category, ending the period at 1.84x and remains the highest P/TBV multiple for all categories. P/E was also up, closing April at 16.34x.




