MONTHLY STOCK PERFORMANCE REPORT OVERVIEW OF MARKET PERFORMANCE BY PEER GROUP

As of March 31, 2022, the number of California banks and thrifts in the Monthly Stock Report was down by one from prior month-end to a total of 76 such institutions, due to the acquisition of Valley Republic Bancorp, Inc. (VLLX) during the month. Except for this change, the composition of banks within the asset categories in the Monthly Stock Report was unchanged from prior month-end.

Note: due to the low number of publicly-traded banks in the "Under \$150M" and "\$150M—\$250M" asset categories, those two categories have been combined into a single asset category of "Under \$250M" starting with the January 2022 report.

Under \$250M — 4 Institutions

Group count and composition of publicly-traded banks with assets under \$250M held constant during the period. Of the 4 banks in this asset category, 2 reported monthly price declines and 2 had no price change. The Price-to-Tangible-Book Value (P/TBV) and Price-to-LTM Earnings (P/E) ratios were not reported for any of the banks in this asset category.

\$250M-\$500M — 12 Institutions

Group count and composition of publicly-traded banks in the \$250M—\$500M asset range held constant during the period. Of the 12 banks in this asset category, 5 reported monthly price gains, while 7 reported price declines. One bank (LIBC) reported monthly price gain of over 10% during the period. LIBC's share price was up more than 40% following its announced acquisition by DMG Bancshares. The group's average P/TBV ratio was unchanged at 1.03x. Average P/E ratio was up, ending the month at 12.78x compared to 11.49x at prior month-end.

\$500M-\$1B — 11 Institutions

Group count and composition of publicly-traded banks in the \$500M—\$1B asset range held constant during the period. Of the 11 banks in this asset group, 3 reported monthly price gains, while 8 reported price declines. No bank reported monthly price gain of over 10% during the period. The group's average P/TBV and average P/E ratios were both down, ending the month at 1.13x and 8.49x, respectively, compared to 1.14x and 9.16x, respectively, at prior month-end.

California Banks & Thrifts: Overview of Market Performance by Asset Group for March 2022

\$1B-\$5B — 29 Institutions

Group count of publicly-traded in the \$1B—\$5B asset category dropped by one during the period as the acquisition of Valley Republic Bancorp, Inc. (VLLX) by TriCo Bancshares was completed during the month. Other than this change, the composition of banks in this asset category was unchanged. Of the 29 banks in this category, 9 reported monthly price gains, while 20 reported price declines. No bank reported monthly price gain of over 10% during the period. The group's average P/TBV and average P/E ratios were both down, ending the month at 1.28x and 10.26x, respectively, compared to 1.29x and 10.39x, respectively, at prior month-end.


\$5B-\$10B — 8 Institutions

Group count and composition of publicly-traded banks in the \$5B—\$10B asset category held constant during the period. Of the 8 banks in this asset category, 3 reported monthly price gains, while 5 reported price declines. No bank reported monthly price gain of over 10% during the period. The group's average P/TBV and average P/E ratios were both down, ending the month at 1.58x and 12.74x, respectively, compared to 1.62x and 13.05x, respectively, at prior month-end.

Over \$10B — 12 Institutions*

Group count and composition of publicly-traded banks with assets over \$10B held constant during the period. Of the 12 banks in this asset category, 2 reported monthly price gains, while 10 reported price declines. One bank (SI) reported monthly price gain of over 10% during the period. The group's average P/TBV and average P/E ratios were both down, ending the month at 1.94x and 15.64x, respectively, compared to 2.04x and 15.85x, respectively, at prior monthend.
